DOROTHY McGONIGLE – SECRETARY (GOING INTO THE SEVENTH YEAR!) Past Activities

Sunday February 23rd Rock Swap at Stuart Park, Wollongong. The day started early for most of the stall holders setting up at about 7 a m in dull and dismal conditions with just a hint of the sun breaking through. By mid morning it wa a glorious warm and sunny day. Lots of people wandering round and buying. From what I could see most stalls were getting a fair share of people buying up the rockas and finished items. The three rock scrambles were a hit with the children, one child turning up at my stall with a shirt turned up and full of his trophies. By 2 p m most were packing up and leaving their patch tidy so that by 2.30 p m the park was back to normal. **Mineral Group** 

Fourteen members attended and Aaron gave a report on his purchases at the rock swap last Sunday. The four identification minerals were; garnet, amazonite, glouberite and gaspeite. Coral did a good job with four good specimens. Don presented his item of interest as the pseudomorph of quartz once heated. Michael presented zircon as the mineral of the month. Zircon (zirconium silicate- ZrSiO4) is uncommon in most rock shops because attractive specimens are rare. The typical simple crystal of zircon is a tetragonal prism terminated with four sided pyramids at each end. The prism may be lacking and the crystal can look octahedral. More complex crystals have faces of a less steeply inclined prism that taper the terminations. Peter did the power point presentation in Keith's absence. There were two presentations, the first on large gypsum deposits some four kilometers underground in Mexico and the second the formation of thunder eggs. The topic of the month was presented by John as Noel is overseas. The topic was a continuation from last month - the family of minerals 2. The zeolite group of minerals was discussed by John.
